Launch Terms and Conditions *

1. NO SPECTATORS should accompany a launch participant onto the site
2. Launch participants will have an allocated launch time, and should not arrive any more than 10 minutes prior to that time.
3. Launch participants also have a departure time, usually 2 hours after arrival. Due to social distancing, Bonkers are limiting the amount of people on site at any one time.
4. Access to the toilets is included. Access to changing rooms will only be possible if and when Covid restrictions allow and if they are not being used by other participants.
5. The participant is entirely responsible for their own safety and their own insurance. Bonkers Activities accept no responsibility what so ever for 'private launch' from the centre, once they are on the water.
6. All vehicles are left entirely at the risk of the participant. Bonkers, and the Pershore Riverside Centre accept no responsibility or liability for any damage to any vehicle whilst on site.
7. All craft on the River Avon require a waterways license and 3rd party insurance. Paddleboarders usually fulfill this requirement by being an 'on water member' of British Canoeing. It is entirely the responsibility of the participant to have their own river license and insurance.
8. Any equipment or valuables are left on site entirely at the risk of the participant. Bonkers accept no responsibility for equipment or valuables left on site.
9. Any 'routes' or 'trails' or 'journey planning' or 'places to paddle' or 'safety tips' discussed with Bonkers staff is purely in an advisory role. The launch participant is entirely responsible for where they go and what they do.
10. Bonkers are not responsible or liable for any loss or damage to any 3rd parties as a result of the actions of the launch participant. Any damage or loss is entirely the responsibility of the launch participant.
11. Participants should obey the 'rules of the road' whilst on the river . For example, pass boats by staying on the right hand side of the river and do not cross the navigation unless it is clear
